OUR THEMATIC PRIORITIES

- To provide quality care and support for the mental and physical health and wellbeing of people affected by dying, death and bereavement.
- To end financial insecurity at end of life, and ensure that everyone has the support they need to address their practical concerns.
- To ensure that everyone affected by death and dying

 including the family, friends and carers of the dying
 person are supported through and beyond the
 end of life.
- To end inequity in end of life experience by ensuring access to excellent standards of care and support for all.

OUR APPROACH TO THESE THEMES

- We take a systems approach, recognising that major improvements in end of life experience must be delivered through action across the thematic areas.
- We make sure the voice of those affected by death, dying and bereavement are at the heart of all we do.
- We ensure that questions relating to the financial resourcing of palliative and end of life care are addressed throughout our work.

WORKING ACROSS THE UK NATIONS AND IN LOCALITIES

- We build on our exceptionally strong research and policy presence across the devolved UK nations to develop and strengthen our work there, ensuring our research is always relevant and usable.
